



**Consent & Information**  
**Free Time Winter Activity & Intramural Sports**  
**Re: Snow Park**

**All Students - Required**

Rosseau Lake College has, through donations, purchased and constructed a modest snow park including the following features:

- 1) A “drop in” ramp is a permanent structure approximately ten-feet high.
- 2) Multiple metal rails: rainbow rail, battleship, straight. Of varying heights – one-foot to five-feet and lengths of eight-feet to thirty-feet.
- 3) Multiple boxes: wood and plastic construction, varying heights.
- 4) Ramps (jumps): these vary in height from one-foot to four-feet.
- 5) Quarter pipe: curved section constructed primarily of wood.

It is important to note that:

- ✓ Participating RLC students will be scheduled to maintain the park.
- ✓ The area is lit for use after dark but will be open at night ONLY when the lights are on.
- ✓ The park will be used during sports and will be available outside of this time unsupervised.
- ✓ Staff will perform daily inspections of the park to ensure safety and will close the park if deemed a risk.

During the winter months RLC students who would like to use these facilities either formally during sports or during their free time must have their parents sign this consent form. The students are welcome to use the equipment but as parents and guardians, you should be aware that there is risk involved with snowboarding, skiing and snowskating. Injuries can occur. Please complete the following consent form to allow your child's participation in these activities and returning it to Rosseau Lake College.

**Rules**

- 1) Students must have a consent form signed by their parents to use the snow park.
- 2) Staff reserve the right to close the park if deemed unsafe.
- 3) When the gate is closed on the snow ramp the park is closed.
- 4) Students must also sign this consent form to demonstrate recognition of the rules.
- 5) Students must stay within their own abilities and limits.
- 6) Students must not encourage others to attempt maneuvers beyond their abilities.
- 7) Students must put safety above all other considerations at all times, this includes such rules as:
  - ✓ Wearing a proper ski/snowboard/snowskate helmet.
  - ✓ No inversions ever (flips, going upside down). No exceptions!
  - ✓ Walking up the side of the course; getting out of the way when finished one's run.
  - ✓ Only one skier/snowboarder on the drop-in at any time.
  - ✓ Waiting for a clear run.
  - ✓ Wearing proper ski and snowboard clothing.
  - ✓ Using properly maintained equipment for purposes for which it is intended.
  - ✓ No toboggans, snowskates, snow blades, etc on the drop-ins, elevated rails, jumps etc.
  - ✓ Snowskates are to be used in the snowskate area only.
  - ✓ Foul language, boisterous play, purposeful damage or any action or activity that puts other students at risk or diminishes their enjoyment of the park will lead to suspension of the privilege of use.

Location

The park is located on the slope of the hill between the Dining Hall and the Rowntree Family Academic Centre.
